EU4Health – the programme

EU4Health is a clear message that public health is a priority for Europe and it is the instrument to pave the way to a European Health Union (Regulation 2021/522)

- **RESPONSE TO COVID-19** supporting the fight against cross-border health threats and boosting the preparedness and capability to respond effectively to future health crises
- AMBITIOUS VISION will go beyond crisis response to support and complement national health policies for strengthening and modernizing health systems, reducing inequalities and overcome shared challenges
- **THE LARGEST EVER EU INVESTMENT IN HEALTH** over €5.3 bn (current prices) invested in health during the next 7 years (2021-27)







EU4Health – General objectives

EU4Health will provide the means and the instruments for delivering on the EU Health policy. Four general objectives represent the breath and the ambitions of the programme:



Improve & foster health in the Union



Protect people from serious cross-border health threats



 Improve access to medicinal products, medical devices, crisisrelevant products



Strengthen health systems









EU4Health – 10 Specific objectives

Building a European Health Union

Building a European Health Union

- Better preparedness for health emergencies: a reinforced health security framework
- Objectives: Strengthen the EU's health security framework; Resolve weaknesses in coordination identified during the early phase of the COVID-19 pandemic; Improve data reporting
- 2) Pharmaceutical strategy for Europe
- Objectives: supporting competitiveness, innovation and sustainability of the EU's pharmaceutical industry; Promoting a high level of quality and safety standards
- 3) Europe's **Beating Cancer plan**
- Objectives: A set of actions to support, coordinate and supplement Member States' efforts at every stage; Cross-cutting themes include research and innovation
- 4) Regulation on the *European Health Data Space*
- Objectives: Empower individuals to access and control their personal health data; Ensure a consistent framework for the use of individuals' health data for research and innovation



EU4Health – specific objectives

EU4Health will be implemented along <u>ten specific objectives</u> that identify key areas of intervention



- (a) Disease prevention & health promotion;
- (j) International health initiatives & cooperation.

 preparedness & response to
 cross-border health threats;
- (d) Complementing national stockpiling of essential crisis-relevant products;
- (e) Establishing a reserve of medical, healthcare & support staff including training.



 (c) Enhancement of availability, accessibility & affordability of medicinal products, medical devices and crisis-relevant products



- (f) Strengthening health data, digital tools & services, digital transformation of healthcare;
- (g) Enhancing access to healthcare;
- (h) Developing and implementing EU health legislation and evidence-based decision making;
- (i) Integrated work among MS health systems.

LEGAL ENTITIES

- ✓ established in a Member State / overseas territory
- ✓ established in a third country associated to the Programme
- ✓ established in a third country listed in the annual work programme in accordance with the specific rules of the EU4Health Regulation
- ✓ created under Union law or an international organisation

Natural Persons are not eligible for grants under EU4Health

Academia (e.g. public health institutes) and education establishments, civil society organisations supporting the priority areas (health professional associations, patients' organisations, foundations, NGOs and similar entities)

Specific eligibility criteria applicable



EUR 5 million for CVD and diabetes EUR 8 million for sub-topic 1 on cancer EUR 3 million for sub-topic on other NCDs

- EU4Health Programme Committee (exchange of views and opinion on draft work programme)
- Adoption by the Commission: at the earliest before the end of the year
