

Within the [REDACTED] we consider that regulatory considerations should be tackled as early as possible particularly for breakthrough innovations such as the [REDACTED]. For this reason, we actively work at increasing regulatory awareness within academia through various internal activities and presentations during conferences. As well, we consider that regulatory science considerations should be introduced in R&I projects as to allow for early identification of regulatory science research topics (to be brought up to the EMA, EFSA or other competent authorities' regulatory science teams) and initiation of an early dialogue with regulators leading to a better understanding and considerations of the impact of the microbiome-derived innovations and their treatment within various regulatory frameworks. As well this would help early identification by the regulators of consortia of academic experts which could then become a resource for the work related to the development and implementation of future regulatory texts. For this reason, I was hoping you would accept this meeting as to increase awareness on our activities within NCPs, and to hopefully have a better understanding of your position regarding activities in regulatory science within R&I projects. Also, I would like to know if you have some recommendations on how we could promote our expertise in the coming Horizon Europe calls. 

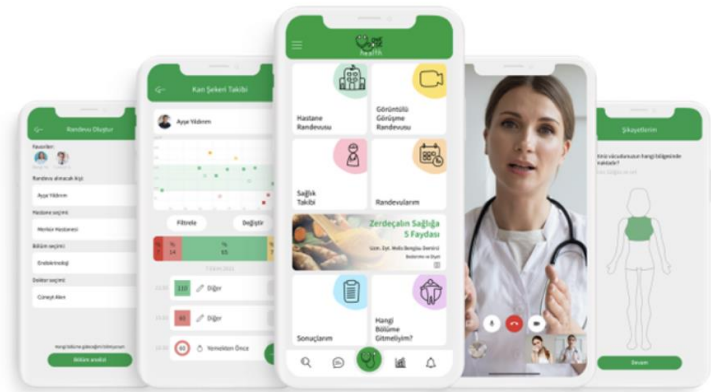

DR. GEDIMINAS MIKULĖNAS

I thought, if I was warned about an impending heart attack, the risk and damage could have been limited or prevented. Therefore, I had this idea to help others who might one day be in my stead.

Dr. Gediminas Mikulėnas graduated from the reinforced school of physics and mathematics in Kaunas, and then in the Kaunas Polytechnic Institute the applied mathematics studies. Doctoral dissertation "Recognition of quasi-periodic bio signals on the basis of correlation theory". The research was recorded in the invention. Dr. Mikulėnas examined the reocephalography (REO) signal (rhography is called impedance). Later, Dr. Mikulėnas also examined oculoagrams (eye movement signals) and ECGs and tried to solve the problems on the basis spectral and correlation analysis. The acquired knowledge helped in the management of start-up investments, implementation of ISO 9001, ISO 9002 standards.



SMART T-SHIRTS

Challenges and needs:

- Rising economic costs and social losses in the health care sector. Hospitals are looking for solutions to the current situation because the time of a cardiologist is expensive. And more severe CVD patients' conditions are leading to higher treatment costs or losses.
- Limited ability to continuously monitor patients at high risk for CVD. Currently, a cardiologist only records an ECG for a short time and this can lead to erroneous AF detection.
- Employee workload. At present, static ECG recording takes about 10 s to monitor a patient for CVD. This is not enough, especially in arrhythmias. Remote and long-term monitoring would reduce the workload of cardiologists. Cardio GEDI would greatly simplify the diagnostic and monitoring process, allow the institution to create added value, and give doctors a unique experience. Some non-essential tasks could be performed remotely, and if cardiac disorders are observed, the patient comes to a cardiologist and is examined in more detail with standard and inpatient clinical equipment.
- Comfort. The device, which is used for a 24-48 hour heart rate monitor, comes with gel sensors and is usually wired. Most portable cardiographs come with wires, which is inconvenient for the patient. Therefore, the patient should wear a device that does not interfere with his daily work.

- Access to health care services. The smart t-shirts will be useful for the person themselves, because they will have the opportunity to monitor their own heart activity. In this way, the patient will receive the desired and understandable information from the device and from the cardiologist. What is more, that for the patient, this could be called partial self-monitoring - feedback, which will be also supervised by a cardiologist if necessary.
- One of the solutions to the above-mentioned challenges, which is not currently solved by the existing solutions, would be the smart t-shirt we are developing.
