

## Objectives and scope:

- Fostering the uptake of digital technologies by businesses, citizens and public administrations
- Enhancing digital skills of the (future) workforce
- A very broad range of different sectors
- **Does not fund research**
- Restricted participation due for security reasons and to strengthen EU's strategic autonomy

**Funding instrument and rate:** Simple grant (up to 50%); **SME Support Action** (up to 75% for SMEs); Coordinated and support actions (up to 100%); Financial Support to Third Parties (up to 100% for consortium, 50% for cascading grants)

**Targets/Stakeholders:** SMEs and larger companies; Knowledge and higher education institutions and research centres; Public sector organisations

- **[Deployment of cutting-edge multi-modal AI-based solutions in medical imaging](#)** Accelerate the adoption of EU AI-driven solutions for deployment in healthcare settings for patient care, which can also be leveraged for research purposes. € 14,4 Mio | SME support action

*INDICATIVE TIMELINE: Q2 2026 – Q3 2026*

- **Apply AI: Piloting AI-based image screening in medical centres** Pilot project(s) to deploy a cloud-based AI/GenAI system using trustworthy and safe AI/GenAI algorithms that were developed, trained, and validated with large patient datasets. € 9 Mio | Simple grant
- **Excellence in higher education and training programmes in key digital areas and applied technologies | Second work strand: Advanced Digital Skills for Digital Health** Expand the offer of education and training opportunities in digital health jointly designed between higher education and training institutions, research organisations and industry. € 7,8 Mio | Lump sum grant
- **Building capacity to deploy the EEHRxF and digital health services and systems to support the rights of citizens and reuse of health data under EHDS** Capacity building of public authorities and healthcare providers to deploy, at a large-scale, services and systems that support the rights of natural persons foreseen under the EHDS € 14,4 Mio € | Grant for financial support to third parties

*INDICATIVE TIMELINE: Q1 2027 – Q2 2027*

- **Testing GenAI4EU applications at scale and under real-world conditions** Integrate GenAI into sectorial testing and experimentation facilities (TEFs) to facilitate the transition of GenAI solutions from lab environments to real-world applications. € 16 Mio | Simple grant
- **Virtual Human Twins and AI in health | Work strand 2: Uptake incubator** Support an uptake incubator for VHT and related AI solutions targeted to developers and innovators € 7,2 Mio | Simple grant

**Funding instrument and rate:** grants, tenders and procurement, up to 60%, up to 80% for “exceptional utility”.

**Targets/Stakeholders:** Local/regional/national authorities, academia, industry, networks.

**Types of projects:** Health policy implementation, health crisis management, public health campaigns, training programs, and digital health initiatives.
