The three planned COFUND actions relating to European partnerships (HORIZON-HLTH-2026-02-DISEASE-12, HORIZON-HLTH-2026-03-DISEASE-13, HORIZON-HLTH-2026-04-CARE-04) are not included in the list below, as they are aimed at national funders and not at the general research community.

General Information for the Horizon Europe Work Programme 2026-2027 - Health:

- **Blind Evaluation:** If indicated in the specific call/topic conditions, first-stage proposals of two-stage submissions will be evaluated blindly and applicants must not disclose their identity in the proposal abstract and Part B of their proposal.
- **China eligibility to participate:**
 - o Legal entities established in China are not eligible to participate in both RIAs and IAs under all destinations. Exceptions may be granted on a case-by-case basis for justified reasons.
 - o For additional information, especially on the eligibility for entities controlled by China or by a legal entity established in China, please see the [Annex B](#) of the [General Annexes of the Work Programme 2026-2027](#).
- **Clinical Studies** are understood here as they are defined by the EU Commission in the "[Information on Clinical Studies](#)" document. If any planned activity within the project falls under this definition of a clinical study, this additional template should be used. The use of this template is expected for single-stage or stage-2 proposals. Please be advised that the template is offered for all topics in the Cluster Health. This does not mean that it is mandatory for all proposals submitted under Cluster Health topics. - **European Research Infrastructures** (ERIs) may be exploited. Find an overview of the relevant [Health Research Infrastructures on our website](#). Health Research Infrastructures are networks, facilities, services, and resources that support high-quality, collaborative, and sustainable health research across European countries.
- **FAIR data:** FAIR data are data which meet the principles of findability, accessibility, interoperability, and reusability. Data may include, amongst others, exploitation of information, digital research data generated in the action, data from European research infrastructures and programmes such as Copernicus, European Space Agency and the GEO initiative. - The **JRC may participate** as member of the consortium selected for funding as a beneficiary with zero funding, or as an associated partner. The JRC will not participate in the preparation and submission of the proposal.
- **Lumps sum funding** in Horizon Europe projects is a simplified form of EU funding where the grant amount is fixed in advance and does not depend on the actual costs incurred. The EU Commission provides a collection of the most important information, guiding documents and links (including to recordings of past events) on [Lump sum Funding on the Funding and Tenders portal](#).

- **Pre-Commercial Procurement (PCP)** in Horizon Europe serves to promote research and development services in a competitive manner for a specific product or service that is not yet commercially available. - **Portfolio Approach:** To ensure a balanced project portfolio, in some topics grants will be awarded (within available budget) to proposals not only in order of ranking but at least also to those proposals that are the highest ranked within different focus areas mentioned in the topic text (e.g. different viruses targeted). Provided that the proposals attain all thresholds.
- **SMEs:** Participation of start-ups, micro, small and medium-sized enterprises (SMEs) is also encouraged.
- **SSH** is listed in the table for those topics where it is specifically mentioned in the topic text. A specific analysis of SSH-relevant Topics in Work Programme 2026-2027 was done by Net4Society, the transnational network for Cluster 2 "Culture, Creativity and Inclusive Society", National Contact Points in Horizon Europe and published in the document "[Opportunities for Researchers from the Social Sciences and Humanities \(SSH\) in Horizon Europe](#)".
- **USA eligibility for funding:** In recognition of the opening of the US National Institutes of Health's programmes to European researchers, legal entities established in the United States of America may exceptionally participate as a beneficiary or affiliated entity, and are eligible to receive Union funding except for *HORIZON-HLTH-2027-03-TOOL-08: Towards Artificial General Intelligence (AGI) for healthcare* (limited to legal entities established in MS and AC).
